

EQUITY ACTIVITIES

E9 Insight was contracted by the Institute for Market Transformation to research equity and decarbonization mandates.

DEFINITIONS

"Equity" policies were defined as those that explicitly support equitable outcomes beyond the traditional definition of low-income programming, especially through measures that support environmental justice, disadvantaged communities, diversity and inclusion, engagement, or reduced energy burden.

A KEY TAKEAWAY

Advocates and experts cautioned against "equitable" programs that do not center affordability and energy **security** issues. To truly pursue equity, policymakers must address:

- Disconnections (esp. by zip code)
- Bill assistance
- LIHEAP funding
- Proceeding participation & accessibility
- Billing practices
 Data sharing (i.e. late fees)
- Internal PUC practices

- Multifamily programs
 - Workforce and contractor diversity
- PUC diversity and inclusion
- Proximity to generating plants
- Community DER
